Dr. Donna Beegle grew up in generational, migrant-labor poverty and was essentially homeless the first 26 years of her life. She is the only member of her family who has not been incarcerated. At 15, she left school to get married and start a family. But, at 25, she found herself with two children, no husband, little education, few job skills, and no access to affordable housing. With the help of Community Action and mentors, she received stable housing and was able to achieve her GED and later her doctorate in educational leadership. She focused her studies and research on understanding poverty impacts and solutions for assisting children and adults to move out and stay out of the crisis of poverty.

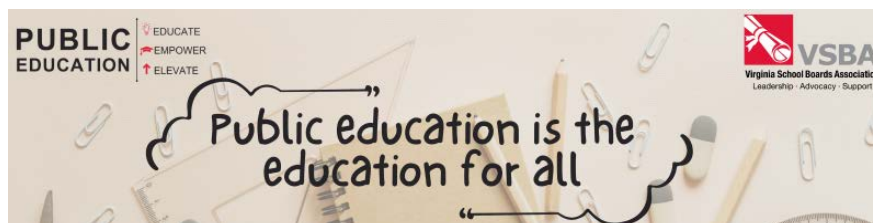

Remote Teacher Mentors Increase Student Learning Outcomes in Bath County

Many teachers in small and remote school districts work on islands. For instance, there may only be one biology teacher in the entire school district. Bath County Public Schools has consistently placed new teachers with mentors for either one or two years. While these mentors provided support in general policy areas, they were not always aligned content experts. With new physical science, earth science, and biology teachers for the 2023-24 school year, leadership knew they needed to plan strategically. With the assistance and guidance of the Comprehensive Instructional Program (CIP), the district strategically selected teacher mentors who demonstrated high levels of success in the subject area. Bath County High School (BCHS) Science SOL pass rates increased to 80.00% compared to 53.41% for the previous year. Further, the school achieved Level I Performance for all school quality indicators including subgroup populations. In fact, BCHS was the second most improved school regarding SOL pass rates for all academic disciplines in the CIP consortium which includes in excess of 400 school members.

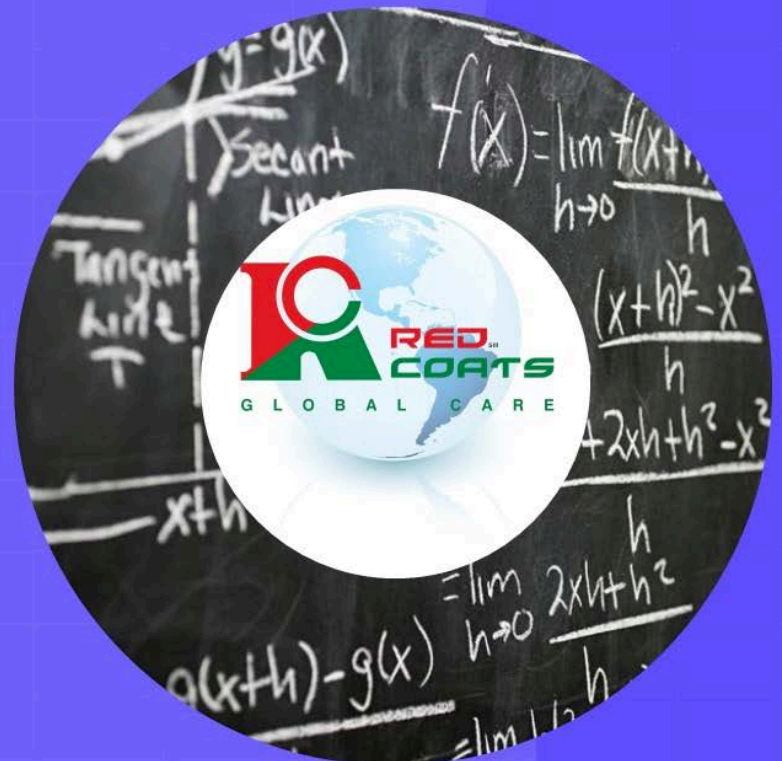

VSBA's members are locally appointed or elected school boards educating over 1 million public school students in Virginia. With input from communities, staff, students, parents, and families, school boards establish policies that are considered and voted on at school board meetings. The formal adoption of these positions follows the Commonwealth's democratic process outlined in the Constitution of Virginia, the Rules of the Senate, and the Rules of the Virginia House of Delegates. Here is a side-by-side comparison of both:

Virginia's Legislative Process

State legislators are elected by a majority of voters within their legislative district.



A Delegate or Senator brings forth a bill that represents the interests of their constituents. Bills that fail to move through the process favorably are considered dead for the session.



Members of the House Education Committee, Senate Education, and Health Committee meet in public session review and vote on the bill. If favorable, the Committees then report the bill to the floor of either chamber.



The bill then goes through first and second readings. Once the bill passes the second reading, it is engrossed. The third reading then takes place, the bill is voted on and approved by the House or Senate.



The bill then goes through a similar procedure in the opposite chamber. Once passed by both houses of the General Assembly, it is sent to the Governor for approval.

VSBA's Legislative Process

State school board members are elected or appointed in accordance with their local process.



Each spring the VSBA Legislative Positions Committee contacts each school board and requests recommendations on legislative positions.



The Committee reviews all suggestions and recommends changes to the Board of Directors. Approved proposals are sent to members of the Delegate Assembly.



Delegates are appointed by individual school boards and share the responsibility to elect VSBA officers, adopt amendments to VSBA's Bylaws, and vote on submitted legislative positions.



During the Delegate Assembly, Delegates vote on the submitted positions. A majority vote of delegates present is required to approve a submitted position. These legislative positions then shape VSBA's legislative agenda.

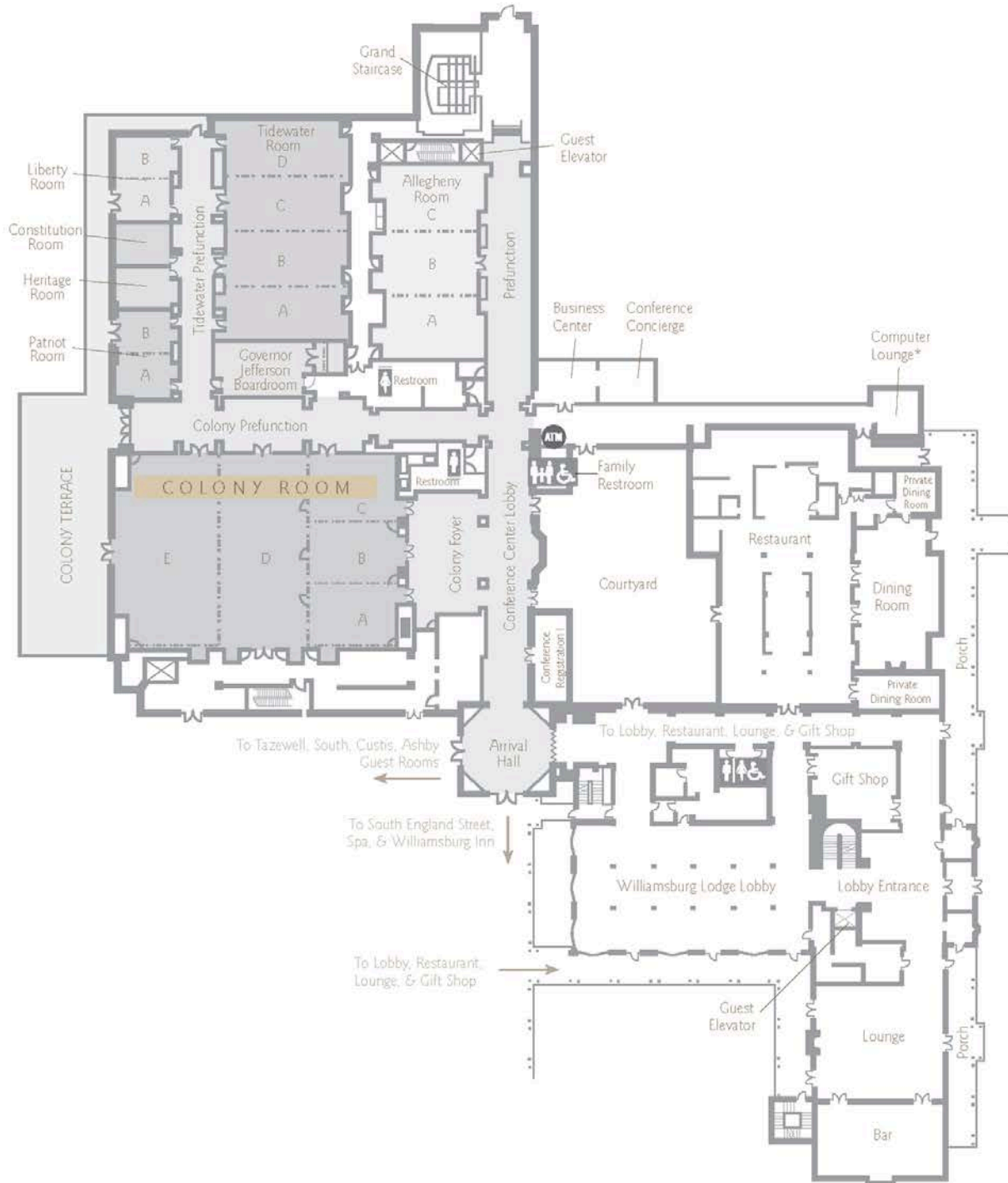

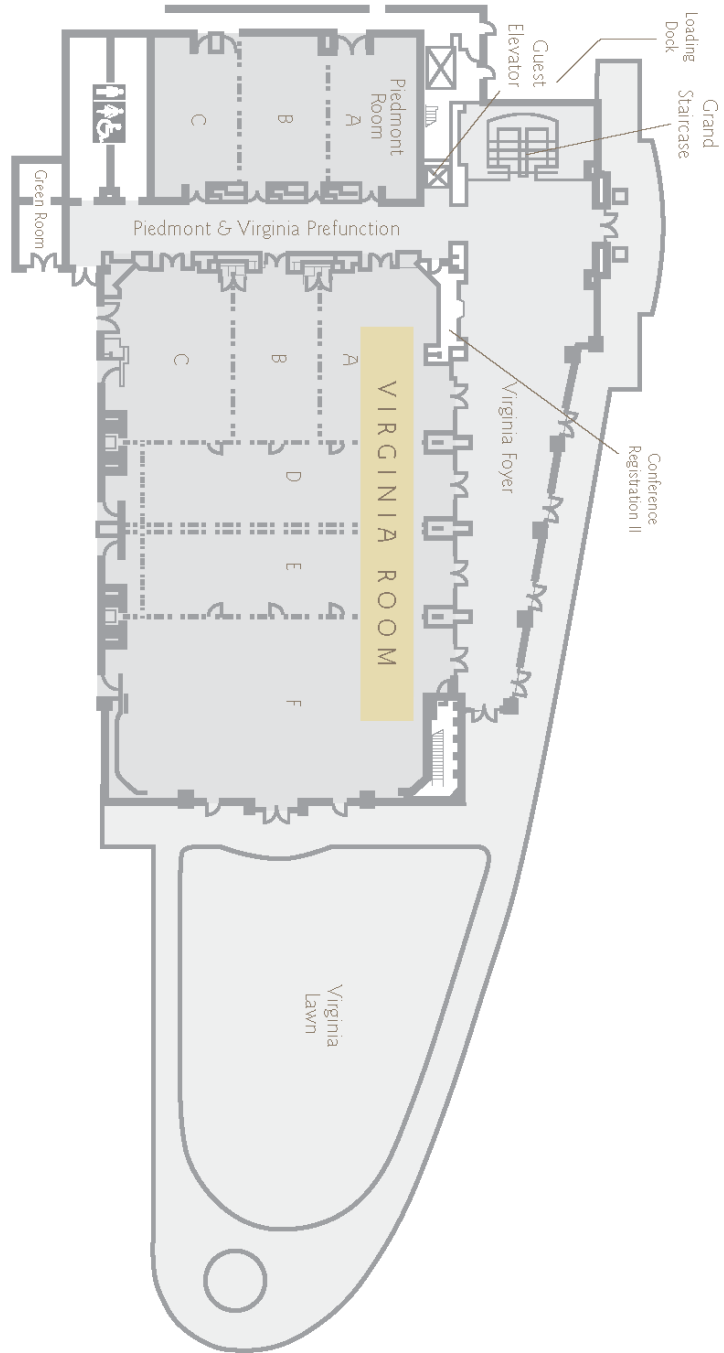
